WEBINAR ON "Changes in the 119th U.S. Congress" by Mary B. Klein

Kicking off the first webinar of 2025, National Association of Clean Water Agencies' (NACWA) Government Affairs Director, Matthew McKenna provided an informative program on changes in Congressional leadership for key environmental, infrastructure, and energy committees.



Mr. McKenna gave some insight on the new members of the major committees, some of which are from our surrounding

Washington DC area. Changes in the Senate Environmental and Public Works Committee (EPW) included the new Republican Chair, Sen. Shelley Moore-Capito (R-WV) and the new Democratic Ranking Member, Sen. Sheldon Whitehouse (D-RI), along with new Senate members Sen. John Curtis (R-UT), Sen. John Husted (R-OH), Sen. Adam Schiff (D-CA), Sen. Lisa Blunt Rochester (D-DE), and Sen. Angela Alsobrooks (D-MD). In the House Transportation and Infrastructure (T&I) Committee, the Republican Chair is Rep. Sam Graves (R-MO) and the Democratic Ranking Member is Rep. Rick Larsen (D-WA). New leadership for the House T&I Water Resource Subcommittee is Republican Chair, Rep. Mike Collins (R-GA) and Democratic Ranking Member Rep., Frederica Wilson (D-FL). Mr. McKenna introduced "newish" leadership for the House



Energy and Commerce (E&C) Committee with new Republican Chair, Rep. Brett Guthrie (R-KY) and Democratic Ranking Member Rep. Frank Pallone (D-NJ), and for the E&C Environment Subcommittee (picture left), the new Republican Chair Rep. Morgan Griffith (R-VA) and Democratic Ranking Member Rep. Paul Tonko (D-NY).

The top three areas that NACWA will be focused on working on for bipartisan support mentioned by Mr.. McKenna included tackling water affordability, working on per- and polyfluoroalkyl substances (PFAS) to ensure polluters, not the public pay for addressing the problem, and investing in America's critical water infrastructure.
